This means that you must send your own nomination form from your own email address, and your proposer/seconder must do so from theirs.

If you are standing in the Show Participant category, you must include written confirmation from your performing company (which must be registered with the Edinburgh Festival Fringe Society for 2025) that you have the authority to stand.

If you are standing in the Venue category, you must include written confirmation from your venue (which must be registered with the Edinburgh Festival Fringe Society for 2025) that you have the authority to stand.

The Fringe Society will seek the necessary evidence of your eligibility to stand. This will include confirming the membership of you, your proposer and your seconder, and evidence of eligibility for your category (ie checking you have a show registered with the Edinburgh Festival Fringe Society for 2025).
